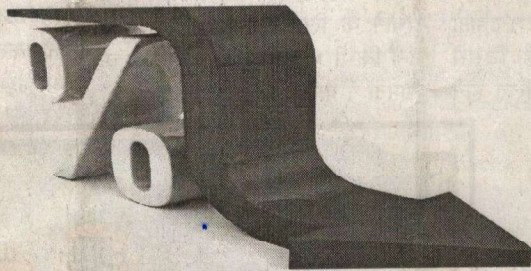

दूसरी तिमाही के लिए जीडीपी वृद्धि अनुमान को ऊपर की ओर संशोधित किया है। संवाददाता सम्मेलन में डिप्टी गवर्नर टी. रबी शंकर ने कहा कि आरबीआई सरकार के उधारी कार्यक्रम का प्रबंधन आराम से कर सकेगा। उन्होंने बताया कि आगामी वित्त वर्ष के दौरान सरकार की सकल उधारी 17.2 लाख करोड़ रुपये और शुद्ध उधारी 11.73 लाख करोड़ रुपये निर्धारित की गई

है। मल्लोत्रा ने कहा कि ट्रेजरी बिल (सरकारी प्रतिभूति) प्रतिफल दर को संभालने में मदद करेंगे और सरकार 11.73 लाख करोड़ रुपये की शुद्ध उधारी उचित दर पर जुटा सकेगी। डेटा केंद्रों से जुड़े बजट ऐलान पर गवर्नर ने कहा कि इससे बड़ी मात्रा में विदेशी निवेश आएगा। एक सवाल के जवाब में मल्लोत्रा ने कहा कि पिछले एक वर्ष में चलन में मौजूद मुद्रा में काफी वृद्धि हुई है।

बजट तेज, समावेशी वृद्धि की दिशा प्रदान करता है: नीति आयोग के सदस्य



नयी दिल्ली@एजेंसी। नीति आयोग के सदस्य अरविंद विरमानी ने कहा कि केंद्रीय बजट कौशल विकास पर जोर देते हुए 'निरंतर, तेज और समावेशी वृद्धि' की दिशा प्रदान करता है। विरमानी ने इस बात पर जोर दिया कि भविष्य में कौशल विकास और सेवा क्षेत्र देश की तस्वीर बदल देंगे क्योंकि इनमें रोजगार पैदा करने की अपार क्षमता है। वित्त मंत्री निर्मला सीतारमण ने एक फरवरी को 2026-27 के लिए 53.5 लाख करोड़ रुपये का केंद्रीय बजट पेश किया था। इसमें विनिर्माण को बढ़ावा देने के उपाय, वैश्विक डेटा केंद्रों के लिए दीर्घकालिक कर प्रोत्साहन और कृषि व पर्यटन के लिए समर्थन की घोषणा की गई थी। इस बजट को वैश्विक जोखिमों के बीच विकास को बनाए रखने के लिए एक दीर्घकालिक रूपरेखा के रूप में देखा जा रहा है। प्रस्तावों पर चर्चा करते हुए विरमानी ने कहा, 'मेरे नजरिए से इसकी एक सरल परिभाषा है। हमें निरंतर, तेज और समावेशी वृद्धि की आवश्यकता है।' उन्होंने कहा कि बजट निरंतरता के साथ इसी दिशा को प्रशस्त करता है। एक साक्षात्कार में उन्होंने कहा कि कौशल विकास पर काफी जोर दिया गया है, जिससे मध्यम अवधि में विशेष रूप से मध्यम वर्ग को मदद मिलेगी।
